B. PRINCIPAL:

1) ESSA and MTSS Meeting Updates:

ESSA requires states to annually designate schools for Targeted Support and Improvement (TSI) beginning 2019-20.

Susan Roth, Principal/CAO, attended the regional session on December 4, 2019 and received briefings on the technical and communication supports regarding Sylvan Heights Target Support and Improvement designation.

- Warning received in the areas of Math-
 - \circ Target = 28% proficient.
- PDE provided targeted schools with a School Plan Template
 - \circ $\;$ Identify a School Improvement Facilitator and Committee.
 - Identify and create an action plan to strengthen our current Comprehensive Plan in the areas of Math.
 - Ideally put the plan into place in January with the intention of positively impacting PSSA Math scores.
- Note: Attendance and Reading Scores are meeting their expected targeted growth requirements. Schools are expected continue to show growth until all targets have been satisfied.

MTSS Meeting: Held December 12th at Sylvan Heights with our Capital Area Intermediate Unit MTSS Consultant. (Note- we are assigned the same consultant to support our TSI initiative).

- \circ $\;$ Review initial benchmark data in the areas of reading and math
- Grade level meetings are being held 2-3 times per month to review progress monitoring scores and ways to strengthen instruction and assessment.
- Recommended the scheduling of Professional Development in the areas of reading instruction and PBIS.
- Recommended providing additional layers of math instruction.
- Follow-up MTSS meetings to occur post January Benchmark testing window.

- 2) Attracting qualified candidates: Online Recruiting Tool
 - R.E.A.P. provides a simple, quick and flexible system for advertising job openings, collecting applicant data and conducting customized searches for the most qualified applicant. The data base contains a tremendous wealth of information. Using it is easy and a variety of customizing and search options help narrow applicant searches to produce only those select individuals meeting specific requirements.
 - One time start-up fee for \$500.
 - Annual membership fee of \$849.
 - Recommendation to suspend the hiring of future Instructional Assistants and instead hiring one certified Elementary teacher.

 - School staff to receive Professional Development in March
 - Core staff to receive supplemental training off-hours
 - Report Form for Complaints of Discrimination (attachment to policy 103.1)

 - Recommend the removal of faulty water fountain system (located between boys and girls bathrooms). Students will have access to water cooler located within the multipurpose room. Refillable water bottles will be provided to students as needed.
