### **B. PRINCIPAL:**

COVID-19 Updates:

- On Friday, October 8<sup>th</sup>, in response to receiving confirmation of another confirmed COVID-19 positive case, it was determined that the school should move towards online instruction. The School gave parents the option to pick up their students starting at 1:00 pm. Students were sent home with their i-Pads, and other arrangements were made for students who were absent that day. Online learning began on October 12<sup>th</sup> and will continue through October 20<sup>th</sup>. In-person learning will resume on Thursday, October 21<sup>st</sup>.
- October 11th Professional Development: Staff participated in virtual professional development on the following topics: 95% Group Phonics Reading Curriculum, Imagine Learning, DreamBox, Safety and Security procedures, and the SAVVAS math curriculum.
- Recommended revisions to the School's ARP ESSER Health & Safety Plan:
  - Update the current mask mandate to include disciplinary action of staff who do not follow the Department of Health's August 31, 2021order.

- Install and keep supplied a mask supply station inside the 13<sup>th</sup> Street vestibule for access to all individuals entering the school building.
- Install and keep supplied a mask supply station inside the playground entrance for all students returning from recess.

#### ARP ECY Homeless Grant:

• Sylvan Heights Science Charter School was awarded \$5,285.00 to assist students who have been identified as homeless. The School will use the funds to provide clothing, shoes, undergarments, school supplies, backpacks, toiletries, personal hygiene, and laundry detergent. The School will also utilize the funds to create bilingual flyers/mailers to assist with the identification of children experiencing homelessness. The performance period of this grant extends from July 1, 2021 to September 30<sup>th</sup> 2024.
